

## PITFALL #1:

# Waiting too long to hire an Attorney

Hiring a great attorney to guide you through the DWI process is an important first step. You want to make sure you make the correct decision, choosing someone you can trust. Though, waiting too long to hire an attorney can result in negative, unintended consequences.

If you wait more than 15 days in a DWI case, you may lose your right to challenge your driver's license suspension. This hearing usually occurs 15 days after your arrest, and most experienced DWI attorneys can assist you with this procedure. Our lawyers even include representation for this ALR hearing within our fee structure.

Make sure you hire an attorney who has DWI experience. This involves trying complex cases involving highly technical scientific evidence. Find out how many cases your potential attorney has tried and ask him/her to explain the scientific evidence issues to you.

### Not taking your DWI seriously

DWI is a serious charge that can affect you for the rest of your life if you are convicted. The Texas Department of Public Safety will maintain this record and track your license indefinitely. A DWI can also be a costly offense. The insurance charges, court costs, fees, fines, courses, interlock costs, etc. can easily amount to many thousands of dollars.

If you don't act quickly after being arrested, you could also risk losing your license. DWI defendants face possible probation, fines, or incarceration. You'll want an experienced attorney who spends a considerable amount of time trying DWI cases on your side.


### Not Hiring an Attorney




### PITFALL #4:

# Failing to Request an ALR Hearing to Challenge your License Suspension within 15 days

Not requesting an ALR hearing within 15 days to challenge the suspension of your license can be a big mistake. It can mean losing your license and your way of life. Losing your license makes it difficult for you to maintain your household responsibilities and make it to work on time. There are specific rules that determine the window in which this hearing can be requested.

Also, you'll want to make sure that your attorney has extensive experience appearing at ALR hearings - many of the facts and issues are similar from case to case and experience can help your attorney anticipate problems before they arise. Issuing a subpoena for the officer can also be an important consideration during these hearings. The officer's possible failure to appear can mean the reinstatement of your license.



### PITFALL #5:

### Driving With a Suspended License

You are not permitted to drive once your license has been suspended. Driving anyway can be a serious criminal offense. You can face serious consequences for ignoring this suspension. Under certain circumstances, your attorney may petition the court for an occupational license. If this is granted, the judge may give you permission to drive for work or personal reasons. Driving before this license is granted can be a costly mistake. Make sure to consult your attorney before driving after an arrest.
